The latest on the 2025 Innovation Fund competition

By the February 4 deadline, we received 334 proposals for the 2025 Innovation Fund competition from 70 institutions. These proposals request over \$1.4 billion in funding from the CFI, representing total project costs exceeding \$3.7 billion.

The first stage of the review process will involve virtual Expert Committee meetings, scheduled to take place from March to July 2025. CFI staff are currently finalizing the recruitment of committee members.

Changes to the timeline for the next Innovation Fund competition

Moving forward, the CFI will run Innovation Fund competitions every two years, rather than every two-and-a-half to three years as we have done in the past. As a result, the next competition will be launched in early 2026, with decisions to be made by the CFI's Board of Directors in fall 2027.

The budget for the 2027 competition will be up to \$325 million in capital costs, with up to \$97 million in associated infrastructure operating funding. This allocation will enable us to sustain a comparable level of investment over time, in line with previous competitions.

Changes to how to submit your research security forms in the post-award phase

We have updated the CFI Awards Management System (CAMS) so you can now submit all Risk Assessment Forms (RAFs) and Private-sector partner identification forms directly in the research security module.

Remember that you may need to submit or update these forms if there are changes to a project. For funded projects for which research security requirements apply, institutions are **responsible** until the final financial report is submitted. Specifically, if there are any changes to a funded project that could affect national security risk under the **National Security Guidelines for Research Partnerships**, you will need to submit or update an RAF. Annual financial trend analysis

The CFI conducts an annual financial trend analysis for each institution with active CFI-funded projects. This analysis is a key part of our oversight framework and helps guide our risk-based decisions regarding payments to institutions. It allows us to better align payments with observed spending trends and our experience with each institution. We assess factors such as the frequency of significant project spending delays based on actual costs reported in the latest financial reports, along with other risk factors that may influence our payment decisions, including delays in obtaining timely financial reports and other requested information.

Our analysis is nearing completion, and we will notify your institution in the coming weeks if your planned instalments or reporting requirements will be impacted.
